The Health Insurance Portability and Accountability Act (HIPAA) of 1996 requires businesses to maintain the confidentiality of any health information they collect from their clients, patients and employees. As the operator of a drug and alcohol treatment center, you need to make sure that your facility is HIPAA compliant.

The HIPAA Privacy Rule requires health plans and covered health care providers to develop and distribute a notice that provides a clear, user-friendly explanation of people's rights with respect to their personal health information. A lawyer can help you draft an official HIPAA statement and privacy policy to display at your facility and on your company's website.
