Tax Law for Addiction Treatment Centers

Do you run your own business or treatment center? As a business owner, you might be worried about a possible audit by the Internal Revenue Service (IRS).

Tax requirements for treatment and rehab facilities are the same as most other businesses. You can do your own taxes or hire a bookkeeper or accountant to help you out. But how do you know if you're keeping all business records up to date and complying with all applicable tax laws?

Proactive Versus Preventative Tax Help

Hiring a lawyer that specializes in tax laws will make sure your taxes get done correctly before you ever run into a problem with the IRS. This type of proactive measure may prevent you from being audited in the first place.

Should your facility ever be faced with an audit, based on tax returns

Business Structure Determines Tax Liability

There are different tax requirements depending on your business structure; Sole Proprietorship, Partnership, Corporation, Subchapter S Corporation (S-Corp) or a Limited Liability Company (LLC).

The IRS levies different Federal Income taxes and, depending on your business structure, you may have to pay excise taxes, self-employment taxes, income tax and taxes for employees.

Certain states may award a tax credit for your business if you buy or lease a property in an economically distressed area and then do any improvements, such as restoration, rehabilitation or renovation on the property.

The IRS also offers tax credits for businesses employing veterans or

people with disabilities. Small businesses with fewer than 25 employees covering 50% or more of health care premiums may qualify for the Small Business Health Care Tax Credit. A lawyer with tax law experience can help you figure out the details of some of these programs such as disabled access credit, barrier removal tax deduction, and the work opportunity tax credit.
